## **PLEASE ATTEND THIS VERY IMPORTANT TOWN HALL MEETING!**

Tahoe residents: your sewer rates will go up if the Douglas County Planning Commission and Board of Commissioners don't support this plan!

The Tahoe Township will be assessed an additional \$811,000 per year for 20 years if this plan doesn't pass. There are residents in the valley that are trying to stop this plan.

Tahoe already pays its own way and then some....

- 9.18 % of Douglas County citizens reside in the Tahoe Township
- 1.54 % of all County Roads maintained are at the Lake (2.75 Miles out of 177.44)
- Despite these low percentages, the lake portion of Douglas County Generates: 37.64% of County's Property Tax, 85.96% of County's Room Tax and 85.5% of the Gaming Tax!

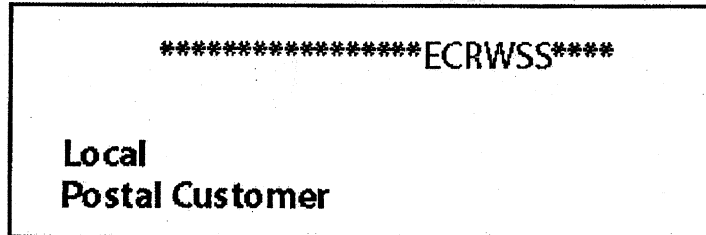
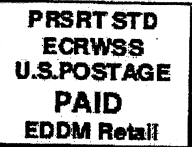
The Douglas County Sewer Improvement District will be giving a presentation to Tahoe Township residents about their unique plan to keep our sewer rates down.
