**1. Meeting Called to Order. (Side A/c#01)**

Meeting was called to order by Chairman Joe Francoeur.

**2. Pledge of Allegiance. (Side A/c#04)**

Pledge of Allegiance was led by Chairman Francoeur.

**3. Roll Call. (Side A/c#06)**

Chairman Joe Francoeur, Vice Chairman Glen Smith, Trustees Wes Rice and Chuck Fagen were present. The District Manager, Administrative Assistant and District Counsel were present. District residents Janet Murphy and Norman Rossman were present.

**4. Public Comment. (Side A/c#11)**

Resident Janet Murphy asked if rates were going to be increased. Chairman Francoeur stated that there were no increases foreseen at this time. He also stated that the Board was just in the process of going over the tariffs and making some necessary updates to items for clarification purposes.

Janet also asked about when the roads were going to be repaired. Chairman Francoeur stated that it was an on going and long process to get the project under way. Her next question was regarding the wages Manager Reed was receiving since the Board at a previous meeting, reported that he would only be reporting to the office one hour each day. Chairman Francoeur stated that the Board would be discussing this issue at this meeting and at a future closed session meeting.
